



An important Etihad Airways update

Virgin Australia Trade Release

Virgin Australia and Qatar Airways have recently applied for approval for an integrated airline alliance. If approved, the proposed alliance will see us deepen our strategic partnership and deliver your customers with improved connectivity on a much wider network of destinations than is currently available.

Our current partnership with Etihad Airways will cease from 1 June 2025.

We are grateful to the Etihad Airways team for their partnership with Virgin Australia over the past 14 years. We will work closely with them and keep our agency partners and customers updated as we transition our partnership over the coming months.

Changes to the Etihad Airways partnership

Bookings with Etihad Airways departing on or before 31 May 2025:

There will be no impact to existing bookings and associated customer benefits for flights departing on or before 31 May 2025.

Bookings with Etihad Airways departing from 1 June 2025 onwards:

- **Points and Status Credit Earn:** Velocity members will no longer earn Velocity Points or Status Credits when flying on Etihad Airways after 31 May 2025.
- **All other frequent flyer benefits:** Etihad Airways lounge access and status recognition will not be available for travel after 31 May 2025.
- **Date changes to travel:** Changes will be permitted up to 12 months from ticket issue, subject to availability. All travel must be completed by 31 May 2026.
- **Missing Points:** Provided your customer was a Velocity member at the time of travel, missing Points for eligible Etihad Airways flights taken on or before 31

May 2025 can be applied for retrospectively via the Velocity Frequent Flyer website no later than 31 December 2025.
